The City of League City's Planning and Zoning Commission and City Council will:

Hold a Public Hearing and consider Zone Change Application, **Z15-04 (Alta Vista Development)**, a request to rezone approximately 8.2 acres from "RSF-5" (Single-family residential with a minimum lot size of 5,000 square feet) and "OS" (Open Space) to "CG" (General Commercial), legally described as a portion of Lots 7 thru 12, all of Lots 1 thru 6, Block 140, all of Lots 1 thru 12, Blocks 170, 200, 230 of Moore's Addition and three (3) abandoned 70-foot wide right-of-way segments of Dakota Avenue, Delaware Avenue and Hawaii Avenue between Olive Street and Peach Street, generally located north of Peach Street, south of Olive Street, east of Idaho Avenue and west of State Highway 3, with the approximate address being in the 2600 block of Highway 3 in League City, Texas.

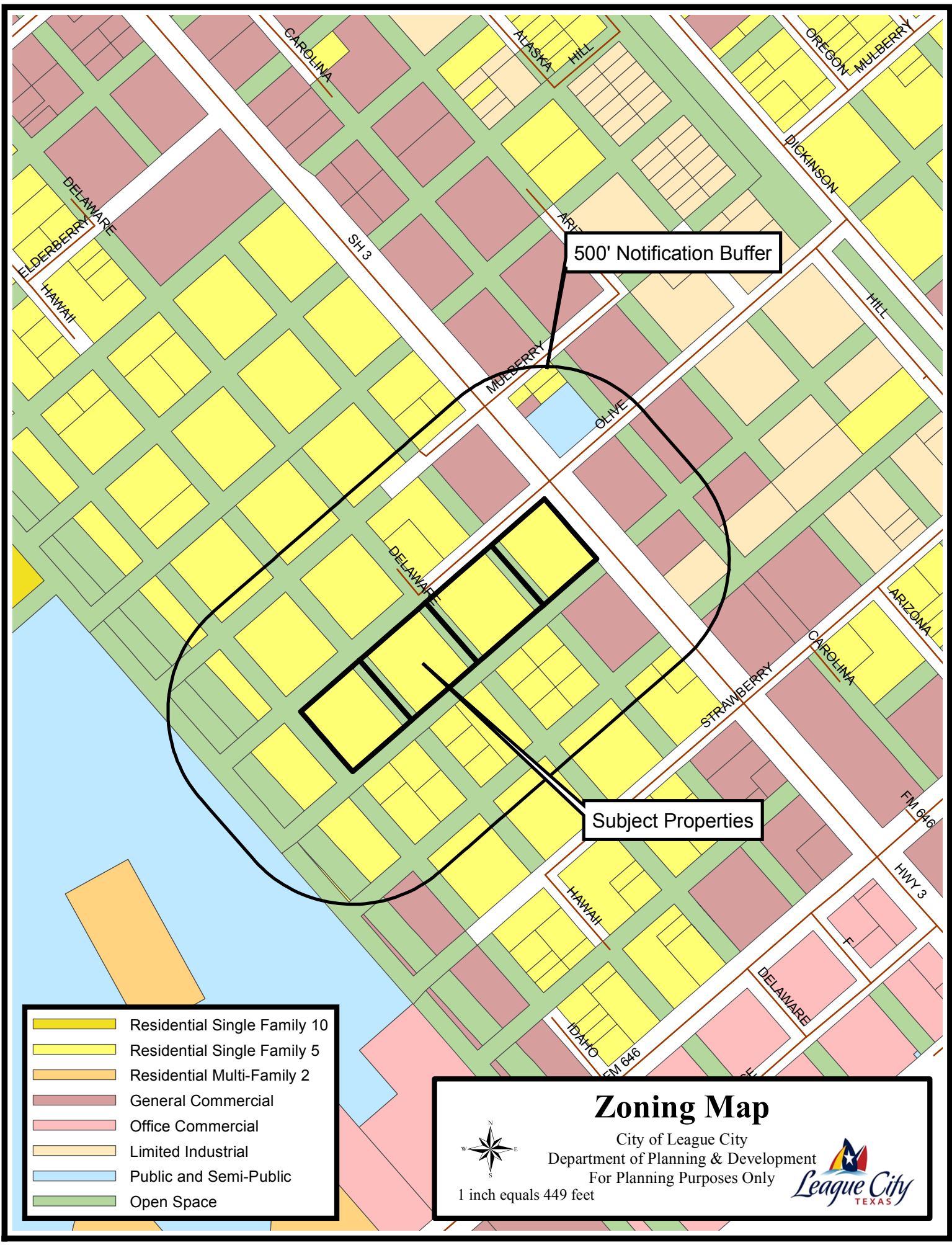

In accordance with Section 211.006(d) of the Texas Local Government Code: "If a proposed change to a regulation or boundary [zoning] is protested in accordance with this subsection, the proposed change must receive, in order to take effect, the affirmative vote of at least three-fourths of all members of the governing body. The protest must be written and signed by the owners of at least 20 percent of either the area of the lots or land covered by the proposed change; or the area of the lots or land immediately adjoining the area covered by the proposed change and extending 200 feet from that area."
